Basic Tagged Fish Contest Rules

Please note: Rules Below are a brief guideline only and are not meant to be all inclusive. The Policy is specific to a particular event and has its own specific Policy Warranties, Terms and Conditions. Specific Warranties, Terms and Conditions are available upon request.

- Only amateurs will be allowed to participate. (An amateur is defined anyone who does not use this sport as a means of livelihood.)
- Only one rod and line will be used per entrant OR as Provincial Rules dictate
- All entrants will be officially registered and no additional registrations will be allowed after commencement of event.
- A witness will sign an affidavit in support of winner's claim.
- A marine biologist or equivalent (authorized by Insurer) will be present to check, examine and verify winning fish.
- Fish presented for claim must be alive and presented the day it is caught.
- Lakes or rivers may not be temporarily dammed for this Event/Tournament.
- The use of nets to catch fish is prohibited.
- A specifically identifiable **non-metallic** tag will be used.
- The location of released tagged fish will not be known to Entrants.
- Tagged fish will be wild or indigenous to the area.
- Record of the point of release of tagged fish will be kept.
- Organizers of the Event and their families and Person(s) who released tagged fish will be excluded from Event/Tournament.
- Three fish per prize will be tagged and the number on the tags will be reported on the Tag & Release Certification to Prize Indemnity Underwriters. Prize Indemnity Underwriters will select the sole winning tag number(s).
- Fish must be released by the Ministry of Natural Resources, a Marine Biologist or an Individual approved by Insurer.
- Tagged fish must be released no less than three days (72 hours) and no more than three weeks (21 days) prior to Event/Tournament date.
- All claims must be presented within seven (7) days of the close of event(s).
- A polygraph of winning Entrant may be required.
- If there is a winning Claim, a photo of the winning fish **CLEARLY** showing the Tag Number and Entrant must be submitted and **WILL** be used to support a Claim.
- The winning Tag Number must not be disclosed until the morning of the tournament.

Any deviation from the Rules above, or Policy Warranties, Terms and Conditions must be discussed with, and approved in writing by Prize Indemnity Underwriters Inc.
